6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 PM on 2078/07/14 (31 Oct 2021) at the office of **K.I. Singh Rural Municipal Executive**. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format which shall be valid for 30 days beyond the validity period of the bid.
